Nursing in Australia

Professional nurses are in great demand in Australia, which means working and migrating to Australia is relatively easy and quick if you meet requirements to be a registered nurse in Australia.

The Australian Healthcare industry offers excellent working conditions for nurses including low patient-nurse ratio, good remuneration, the opportunity for career development and ongoing education. Salaries are governed by the award agreements made between the Australian Nursing Federation (State branches) and the State Government of each state. This means that every nurse is paid based on the years of experience that they have. The award agreements vary slightly between the states.



Nursing in Australia

In Australia, as in most countries, the practice of a profession such as nursing requires evidence of an appropriate level of education and experience. To receive registration, your application process will depend on where you were originally trained, and the skill set you have obtained.

Gaining Registration

Every nurse and midwife is required to obtain registration and maintain a current nursing licence (authority to practice) in order to work in Australia as a RN/RMN.

To register you will need to contact AHPRA, the Nursing and Midwifery Regulatory Authority of Australia. Application forms for registration are available on AHPRA's website (www.ahpra. gov.au).

If your nursing course was completed in Canada, Denmark, Finland, Ireland, Netherlands, New Zealand, Singapore, Sweden, United Kingdom or the United States then, subject to appropriate documentation of your education and evidence that all other education requirements have been satisfied, your education may be considered to constitute adequate qualifications for registration in Australia. Pending further consideration of health care, professional education and professional regulatory systems in Hong Kong, courses undertaken in Hong Kong may also be considered in the same way.

Between New Zealand and Australia, there is an agreement called Mutual Recognition Legislation. What this means is, that once you are registered in either NZ or Australia the process is simplified to gain registration in the other country. You can hold registration in more than one country at any given time.

Guidelines for Registering in Australia as a Nurse or a Midwife

The application for general registration can be found within the AHPRA website, which will redirect you to www.nursingmidwiferyboard.gov.au. Assessment can take anywhere up to 90 days from commencement (when all certified documents have been submitted to APHRA).

The registration requirements are as follows:

SECTION A	Personal details and identification
SECTION B	Application type
SECTION C	Qualification for the profession. You must attach a certified copy of all your academic qualifications.
SECTION D	Registration history. You must contact all of the Nursing Registration Bodies outside of Australia in which you are currently, or have previously been registered as a health practitioner during the last 5 years .
SECTION E	Full practice history. You must provide a 'Statement of Service History' from every employer you've worked with in the past 5 years. Additionally you must include a copy of your CV following all the elements defined in AHPRA's standard format for CVs: www.ahpra.gov.au/Registration/Registration-Process/Standard- Format-for-Curriculum-Vitae.aspx
SECTION F	Suitability statements. This also includes an IELTS test (International English Language Test) if you did not complete your education in English; this can be completed online: http://www.ipassielts.com/hcl
	Proof of Secondary and Tertiary schooling in English
	You must request a letter stating that you were taught and assessed in English on a daily basis. This must be produced on letter headed paper and produced from your secondary school and your University. These must also be notarized by a notary public. Certifying Documents can only be completed in the UK by a notary public. You can find your nearest notary at the following website: http://www.mynotary.co.uk/

Please make sure that you have attached all the documents that are applicable as per the items within the checklist. DO NOT send your application unless you have everything that you are required to send (i.e. all the documents certified correctly, NMC registration requested, proof of IELTS or secondary schooling).



Mailing your registration application form

You must send your application to the AHPRA office in the **state you plan to be working**.

When you have applied for your Nursing board registration, what happens now?

If you feel you can be ready to relocate to Australia within 4-6 months your application will then be passed to a Healthcare Australia consultant in Australia.

It has to be 4-6 months as that is the maximum time an Australian employer will wait for your commencement.

Your CV will be handed over to a consultant who lives and works in the state of Australia in which you are seeking employment.

This consultant will have inside knowledge on the location and have up to date knowledge on all the roles available.

Your Australian consultant will then guide you on the following steps

- Sending your CV to prospective employers in your location of choice
- Arranging Telephone/Skype Interviews
- Offers of employment
- Applying for Sponsorship Visa
- Information on location and temporary accommodation options.

How to apply for your Visa

Once an Australian Healthcare employer has offered you employment, you will need to apply for a 457 Temporary Resident Visa. The direct employer in Australia must first nominate all prospective applicants. If the nomination is approved, the employer will advise the nominee and provide them with a copy of the nomination approval letter from the department.

The nomination has to be lodged by an employer before the online Visa application can be started. You will be provided a 10 digit Nomination approval number similar to: **EGNWQ50AOH**.
