ACROPOLIS FEE STRUCTURE

- Single Applicant: RM 8500 (RM 2500 non-refundable)
- Family Applicant (Upto 4 members): RM 10,000 (RM 2500 non-refundable)
- For a family of more than 4 members, additional RM 500 per dependant.
- Client must pay 50% of the fees at the beginning of application process with Acropolis engagement letter.
- Remaining 50% to be paid after conditional visa approval letter from the immigration department.

OTHER FEES (PER PERSON IN THE FAMILY)

- Medical check-up: RM 350
- Stamping duty: RM 20
- Gov't fee: RM1200
- Verification fee to lawyer: RM100

Handle Application Process

- We provide latest information regarding the terms and conditions about MM2H program.
- We help and assist the applicant to prepare all the required documents for MM2H application.
- We help the applicant to get a sponsor who should sign a Personal Bond with the government of Malaysia to guarantee the good conduct of the participants throughout their stay in Malaysia under this program.
- Inform the applicant about the status of their application until they have received the Conditional Approval letter from Immigration Department.
- Making appeals if necessary for the application approval.
- Advice client to come to Malaysia within 6 months from the date of approval of the Conditional Approval letter to fulfill all the required terms and conditions.

Assist Clients in Complete Relocation to Malaysia

- Arrange for the transportation and accommodation for successful applicants upon their arrival in Malaysia.
- Assist successful applicants to open a fixed deposit account, arrange for insurance policy and medical report (if required).
- Bring successful applicants to the Immigration Department to pay the required visa fees and have their passport stamped with Malaysia My Second Home sticker.
- Alert participants on the types of incentives they can now apply under this program (Car, House and Maid).

- House rental or house purchase
